P Street – SOUTH side for a distance of 45 feet from OCEAN BOULEVARD

2. Designation as a four way stop of the intersection of Concord Ave. and River Rd.

Sec. 3:601 Stop Intersections

Subject to the approval of the State Highway Commissioner, as to the specifications for STOP SIGNS, the Board of Selectmen of the Town of Hampton has hereby established the following STOP INTERSECTIONS. All traffic SHALL STOP on the following designated "STOP STREETS", as indicated by signs, when proceeding in the "Direction of Travel" indicated, before entering, including crossing the following designated "Through Streets":

<u>STOP Street</u>	<u>Direction of Travel and Through Street</u>
River Avenue	NORTHERLY and SOUTHERLY at CONCORD AVENUE

3. Placement of stop sign at the corner of Highland Ave. and Brown Ave.

<u>STOP Street</u>	<u>Direction of Travel and Through Street</u>
Highland Avenue	EASTERLY at BROWN AVENUE

4. Acceptance under RSA 41:14-a of a sidewalk & parking easement at 428 Lafayette Rd. (the first of two required public hearings)
