 1. Work on the Church Street Pump Station is proceeding. The exterior brick veneer is by-in-large completed, construction is proceeding on the loading dock, and electrical equipment and fixtures are being installed in rough in form.
 2. Residents with portable basketball nets that are located on the streets are requested to remove them for the winter so that snow plowing operations will not be impeded. Damage caused by the failure to remove them will not be reimbursed by the Town.
