- A. Any request for Initial Plates must be accompanied by an unprocessed registration permit which is obtained from your Town/City Clerk.
- B. Fee: Registration fee plus \$25.00 Initial Plate fee, plus \$8.00 reflectorized plate fee. There is an additional charge of \$30.00 for Conservation Plates. Make all checks payable to: State of NH- MV.
- C. Availability of Initial Plates will not be verified over the telephone.
- D. All Initial Plate requests shall meet the following restrictions:
 - 1. Letters only (at least two, and "O" cannot be one of the two)
 - 2. A combination of at least two letters and numbers
 - 3. A combination of at least two letters and symbols
 - 4. A combination of at least two letters, symbol(s), and numbers
 - 5. There can be no spaces
 - 6. The only symbols available are: Dash (-), Ampersand (&), and Plus (+)
 - 7. **No** two symbols can appear consecutively

<u>Initial Plate Type</u>	<u>Maximum Letters/Numbers</u>
Passenger	Seven characters
Apportioned, Conservation, Commercial, Trailer, Veteran	Six characters
Antique	Six characters (four with Old Man replica)
Walking Disability, Purple Heart, Street Rod	Four characters
Motorcycle	Five characters (ampersand (&) NOT available)
Veteran Motorcycle	Four characters (ampersand (&) NOT available)
Purple Heart Motorcycle	Three characters (two of which must be letters, Ampersand (&) NOT available)

The Division of Motor Vehicles reserves the right to recall Initial Plates if they are determined to be unacceptable or a complaint is received from the public.

Pursuant to Administrative Rule Saf-C 514.61, the following guidelines should be read carefully before submitting your request:

- 1. Initial Plates shall not have the identical or similar combination of characters as any other classification of plate
- 2. Initial Plates shall not be capable of an obscene interpretation
- 3. Initial Plates shall not be ethnically, racially or which a reasonable person would find offensive to good taste
