5. Operating Budget Adjustment

Warrant Article #45: Cemetery Markers

Mr Welch explained that a private warrant article could not be removed from the ballot and suggested that the warrant article be supported for this year. Mr Warburton moved to remove the \$6,500 from the cemetery line in the Budget concerning markers for veterans in the Hampton Cemetery; Second: Mr Plouffe. Approved: Unanimous.

6. Operating Budget Revised

Mr Bridle moved to the Public Hearing the sum of \$28,322,336 as the adjusted FY2020 Town of Hampton Operating Budget. Second: Mr Plouffe. Approved: Unanimous.

7. 2020 Hampton Town Warrant Articles - continued review

- (i) Warrant Article #29: Communication Systems Improvement. Mr LaBranche moved the sum of \$116,300 to the Public Hearing for the purpose of improving the radio and Town emergency communication systems ...said appropriation to be offset by funds to be received from the state of New Hampshire as unrestricted municipal aid. Second: Mr Maurer. Approved: Unanimous
- (ii) Warrant Article #18: Road Improvements for Winnacunnet Road and High Street.

 Mr Warburton read the entire article. Mr Maurer moved forward to the Public Hearing the sum of \$435,000 from the 1998 Road Improvement Capital Reserve Fund for the survey, engineering and design work for replacing the Winnacunnet Road and High Street sewer and closed drainage system mains, sewer services and related work, to be followed by curbing, signage, street lights etc and paving of the entire roadway...and to authorize the Board of Selectmen to apply for, accept and expend Federal, State and local grants and funds to be added to the project, including the State Revolving Fund...(Zero Tax Impact). Second: Mr Rage. Approved Unanimous.

Mr Welch said in order to advance such a project, and because these streets are major arterial roadways, the Board of Selectmen decided to begin by doing all of the engineering, and then add one or more appropriations to do the work in segments. In response to Mr Plouffe, Mr Welch said the project would include the full length of High Street. If passed at the Town Meeting, more than \$1,000,000 would remain in the Road Improvement Capital Reserve Fund. Mr LaBranche, Mr Plouffe, Mr Rage and Mr Warburton thought doing the engineering first was good planning and good for taxpayers.

8. Hampton Beach Village District.

Mr Rage reported that the District budget work session is scheduled for January 22.
