## CONSERVATION COMMISSION PUBLIC HEARING

January 27, 2009

FINAL

The meeting was called to order at 7:00 p.m. by Acting Chairperson Nathan Page at the Hampton Town Office Meeting Room. Present were Commission Members Jay Diener, Dr. Ralph Falk, Barbara Renaud, and Peter Tilton Jr. Commission Members Ellen Goethel and Sharon Raymond were absent. Alternate Steve Scaturro was present, sitting in for Sharon Raymond. Rayann Richard, Conservation Commission Coordinator, was present. No Planning Board representative was present.

The Minutes of September 23, 2008, October 28, 2008, November 25, 2008, December 1, 2008 and December 30, 2008 were reviewed and accepted with corrections noted.

There was no site walk. Commissioners viewed the site on their own.

## NH WETLAND BUREAU APPLICATION

A. 213 Island Path Pamela Rush

This application is to construct a 20' x 20' garage attached to the existing house, extend an area of the house out 8' between two sections of the existing house and remove 431 sq. ft. of impervious surfaces. This applicant has a dredge and fill and shoreland application. The contractor for the project, Paul Powell, addressed the Commission. After a brief discussion, Mr. Tilton motioned to not oppose the DES application with the Plan dated 12/11/08. Mr. Diener seconded the motion. All were in favor.

B. 4 Chase St STM Trust c/o James Monagle

This application is for the removal of an existing two-family structure and construct a two-family dwelling further away from the tidal ditch. This applicant has a dredge & fill application. After a brief discussion, Ms. Renaud motioned to not oppose the granting of a wetlands permit per the plan with the revision date of January 1, 2009. The proposed work involves the removal of the existing structure and the construction of a new dwelling. If DES approves the granting of this application, the Commission would request the following stipulations be included: (1) area above the below the 2<sup>nd</sup> floor deck and stairs remain open and vegetated and the area under the deck be used for storage; (2) all potential parking areas shall be constructed with permeable pavers; (3) applicant has proposed an infiltration pit for handling storm water runoff from the roof; (4) Commission requires the applicant to provide a landscaping plan to the Conservation Coordinator for approval prior to installation; (5) Commission has concerns about Note #8 on the plan. Based on the note the Commission stipulates that if there are any changes in the dimension of the building footprint which fall outside of the proposed building envelope as per the plan with the revision date of January 1, 2009, then the applicant is required to come back to the Commission for approval of the changes; and (6) Commission would like to be notified at start and completion of the construction. Mr. Tilton seconded. All were in favor.

### SPECIAL PERMIT

A. 213 Island Path Pamela Rush

The proposed work involves the construction of a 20' x 20' garage attached to the existing house, extension of an area of the house 8' between two sections of the existing house and removal of 132 sq. ft. of impervious surfaces. After a brief discussion, Mr. Tilton motioned to grant the Special Permit for with within the 50 ft. Town Wetlands Conservation District buffer per the plan dated December 11, 2008 and signed and dated (1//27/09) by the Vice Chair. The usual stipulations are included. Ms. Renaud seconded the motion. All were in favor.

B. 4 Chase St STM Trust c/o James Monagle

The proposed work involves the removal of the existing structure and the construction of a new dwelling. After a brief discussion, Ms. Renaud motioned to grant the Special Permit for the work within the 50 ft. Town Wetlands Conservation District buffer per the plan with the revision date of January 1, 2009 and signed and dated (1/27/09) by the Vice Chair. The usual stipulations are included. (Please see Page One.) Mr. Scaturro seconded the motion. All were in favor.
