VI. Town Manager's Report

1. Drakeside Road is open to traffic. Paving will be accomplished in the near future. Public Works indicates that only a base course will be installed over the winter with completion of the final layer of asphalt to be placed in the spring after some work on sewer connections a little east of the current construction work.
2. The Town's IT Department has placed up online the test results from Aquarian regarding PFC's. The Town's Landfill tests will be added soon. This will be a continuing process to which will be added any further tests including tests reported by the EPA, DES, Aquarian, and the Town.
3. For those who use Academy Avenue, we suggest that you seek alternate routes because of the construction at Hampton Academy; alternate arrangements have been made for the loading and unloading of school busses, which can cause delays on this roadway.
4. Paving operations are in progress on Route 1 Lafayette Road from Park Avenue in Hampton south to the Massachusetts State Line. Select alternate routes to avoid delays.
