  1. Work continues on the replacement of the Lafayette Sewer Line from Winnacunnet Road to High Street. Work hours are from 9PM to 6AM Sunday through Thursday evenings. Please watch for detours and heavy equipment as well as workers in the roadway.
  2. It is not too early to begin arranging for parking your vehicle during the winter parking ban from November 15 to April 15. Overnight parking is banned on all streets between those dates from 1AM to 7AM.

4. We are requesting that the State plow and clear snow from the main beach parking lots and to allow residents to park without paying fees during the period of the November 15 to April 15 overnight parking ban and during snow emergencies.
